

On Friday, February 23, 2024, DRC's Executive Director, Dolores Nason, and Assistant Director, Mario Rodriguez, visited the Long Beach Rescue Mission for the Ribbon Cutting Ceremony at the John and Helen Apostle House. This 15-bed facility provides wheelchair-accessible housing for men with disabilities who are experiencing homelessness. Apostle House occupies a storefront property already owned by the Rescue Mission. This newly renovated facility incorporates a wheelchair ramp, beds that allow for easy access, and roll-in showers with a built-in bench.


